Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data collectively all information that you submit to Janos Csaszar / Sole Trader, via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws

Cookies a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies)

7. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

1. This privacy policy applies only to the actions of Janos Csaszar / Sole Trader and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
2. For purposes of the applicable Data Protection Laws, Janos Csaszar / Sole Trader is the "data controller". This means that Janos Csaszar / Sole Trader determines the purposes for which, and the manner in which, your Data is processed.

Data collected

1. We may collect the following Data, which includes personal Data, from you:
 1. Name,

in each case, in accordance with this privacy policy.

How we collect Data

1. We collect Data in the following ways:
 2. data is given to us by you, and
 - b. data is collected automatically.

Data that is given to us by you

1. Janos Csaszar / Sole Trader will collect your Data in a number of ways, for example:
 1. when you contact us through the Website, by telephone, post, e-mail or through any other means.
 2. when you register with us and set up an account to receive our products / services.
 3. when you make payments to us, through this Website or otherwise in each case, in accordance with this privacy policy.

Data that is collected automatically

1. To the extent that you access the Website, we will collect your Data automatically, for example:

Our use of Data

1. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

 3. transmission by email of marketing materials that may be of interest to you.

Your rights

 4. Right to restrict our use of your Data - the right to "block" us from using your Data or limit the way in which we can use it.
 5. Right to data portability - the right to request that we move, copy or transfer your Data.
 6. Right to object - the right to object to our use of your Data including where we use it for our legitimate interests.
